Paul and Lucy Melhuish have completed graduate degrees at the University of Oregon and are working toward the Ph.D. They both were at Bowling Green (Ohio).

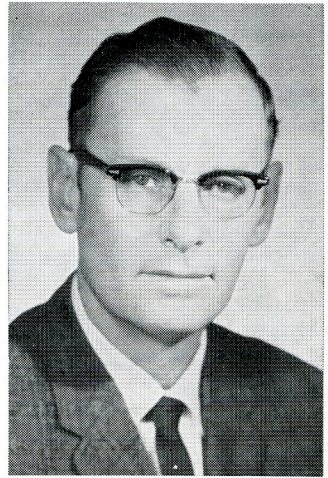
Judy Hafner, who was a member of the squad at Brookings, has returned to Linfield to teach in the speech department.
