SECRETARY-TREASURER REPORT

Tony Allison, Secretary-Treasurer

I want to extend my congratulations to the new chapters that were presented their charters on Wednesday evening. It has been some time since 19 chapters were presented new charters or were reaffiliated at one convention. I appreciate very much the effort of Terry Cole who was the Charter and Standards Committee Chairman.

At this convention we have 35 states represented with a total of 731 people from 110 undergraduate chapters and 6 Alumni chapters.

After the action of the convention we will have a total of 235 chapters. As of this date, 166 chapters have paid their annual chapter fees this year. Since July 15 we have added about 650 members. Last year we received 542 memberships. The increase in memberships from last year to this is no surprise since that is usually the trend for a convention year.

The organization operates mostly from the membership and annual chapter fees. The annual chapter fee was instituted in 1977 and has not been increased since it began. Inflation has been causing us a real problem with the cost of printing and mailing *The Forensic*. The cost of printing and mailing in the National Office has significantly increased. Last year (a year which was not a national tournament year)

the National Office sent out 1812 pieces of mail. This year we'll probably send nearly 3000 pieces of mail.

If you have examined the financial statement ending July 15, 1982 in the *Winter Forensic*, you have noted that we ended the year with almost a \$4,000.00 deficit. We had unusual expenses such as: moving the National Office, reprinting of all brochures and forms, and the carryover and expenses from the Gatlinburg convention.

This year the picture looks brighter with income from the royalties of the PKD Debate Book. We recently received our first royalty check for \$1,165.00. This organization is certainly grateful for those who worked on the debate book.

Our assets at the end of the last fiscal year 1982 were \$25,207.00. Presently we have \$15,000 invested at Home Savings Bank, Lawton, in a fund called Advantage Moneyfund. The PKD financial records are audited each summer by a Certified Public Accountant and the Secretary-Treasurer is bonded.

Now, concerning the needs of the National Office, we need to upgrade the record-keeping in the National Office. A computer is needed badly for the time consuming tasks, which would improve our accuracy and efficiency. We also need a typewriter. We have been using Cameron University typewriters.

PROCEEDINGS OF THE THIRTY-THIRD BIENNIAL CONVENTION OF PI KAPPA DELTA

ESTES PARK, COLORADO

APRIL 13-16, 1983

First Business Meeting

President Jack Starr called the first business meeting of the convention to order at 8:10 p.m. on April 13, 1983. He thanked the band from Winfield, Kansas that

provided music while people were entering the auditorium.

We were led in the pledge of allegiance to the flag.

The invocation was given by Dr. Georgia

Bowman of William Jewell College.

The roll of chapters was called by the Secretary-Treasurer.

Greetings were given by William Zimmerman in behalf of the Chamber of Commerce of Estes Park. Mark Stucky of Bethel College welcomed the convention to the Province of the Plains.

A necrology service was held for Jerry Haggard from Pittsburg State University, the student representative of the National Council. Michelle O'Daniels of Southwestern College and Margaret Greynolds of Georgetown College conducted the service.

Announcements were made by chairmen of various committees.

Nineteen chapters received charters from President Jack Starr and Terry Cole, Chairman of the Charter and Standards Committee. The new charters include: East Central College, Missouri Chi; California Polytechnic State University-San Luis Obispo, California Psi; Oklahoma Christian College, Oklahoma Rho; University of

Sciences and Arts of Oklahoma, Oklahoma Sigma; Incarnate Word College, Texas Alpha Eta; Liberty Baptist College, Virginia Gamma; University of North Carolina-Wilmington, North Carolina Eta; Western Carolina University, North Carolina Theta; Berry College, Georgia Epsilon; University of North Carolina-Charlotte, North Carolina Iota; Fordham University, New York Theta; Queens College, New York Iota; Glenville State College, West Virginia Epsilon.

Two colleges reactivated and received new charters. These were Baker University, Kansas Kappa, and Abilene Christian University, Texas Xi.

There were four Alumni chapters that received new charters. These were: Bloomsburg State College Alumni Chapter; Wilkes College Alumni Chapter; Appalachian State University Alumni Chapter; Georgetown College Alumni Chapter.

A convention picture was made in the auditorium.

The meeting was adjourned at 9:20 p.m.

Second Business Meeting

The second business meeting of the convention was called to order at 7:10 p.m. by President Jack Starr on April 14, 1983.

Carolyn Keefe, of West Chester State, Chair of the Nominating Committee, explained the voting procedure for the election of President and Vice-President. The candidates were Larry Richardson, Penny Swisher, Gary Horn, and Terry Cole. Also on the ballot was the name of Anthony Schroeder of Eastern New Mexico University as Editor of the *Forensic* for a two year term. Anthony Schroeder was nominated by the National Council. The election was held by secret ballot.

Margaret Greynolds gave information concerning the summer PKD Institute which would be held on the Georgetown College campus in July. She showed a film of the campus.

Michael Bartanen of Pacific Lutheran University, Chairman of the Research Committee, gave the history of the commit-

tee and reported that in addition to providing a research issue for the *Forensic*, the committee had two goals in the next two years. One was to focus on Presidential Argumentation and Communication and the second to focus on the Future Directions of Forensics. A motion to file the report was passed.

Gary Horn of Southwestern College gave the Constitutional Revision Committee Report. A motion was passed to delete section 503.1 from the amendment. A motion failed to delete the last sentence in section 503. The motion to accept section 503 was approved. The motion failed to amend the amendment in section 504.1 by changing "five" to "one" new member every biennium for a four year period. A motion was passed to refer the amendment back to committee.

Carolyn Keefe reported the results of the election. Penny Swisher had been elected President and Gary Horn, Vice-President.

Anthony Schroeder was approved as Editor of the *Forensic*.

Announcements were made.
The meeting was adjourned at 9:10 p.m.

Third Business Meeting

President Jack Starr called the meeting to order at 8:10 p.m. on April 15, 1983.

Fred Goodwin, Parliamentarian and Past President, clarified some procedural matters.

Carolyn Keefe, Chair of the Nominating Committee, read the nominations for National Council: Michael Bartanen, Terry Cole, Robert Littlefield, Harry Strine, and David Ray. Jim Norwig was nominated from the floor, but he declined the nomination. The election was held by secret ballot. Each candidate was allowed five minutes for seconding speeches.

Gary Horn, Chairman of the Constitutional Revision Committee, continued his report. The committee changed the word "shall" to "may" in sections 504 and 505. Sections 504, 504.1, 504.2 and 504.3 were adopted. The motion to adopt section 505 was also approved.

Terry Cole, Chairman of the Charter and Standards Committee, gave the committee's report. The Convention approved the chap-

ters that requested disaffiliation. They are: Bethany College (Kansas), Monmouth College (Illinois), Central Connecticut State College, North Texas State University, East Stroudsburg State College (Pennsylvania), Angelo State University (Texas), Northern Michigan University, Mississippi University for Women. The motion to file the charter and standards report was approved.

Tony Allison gave the Secretary-Treasurer's report. A motion was passed to file the report.

Carolyn Keefe announced the names of the new council members. Those elected to serve were: Terry Cole, Robert Littlefield, and David Ray.

Jim Norwig, Chairman of the Convention Evaluation Committee, gave a preview of his report to be given in the next business meeting.

Announcements were made.

The meeting was adjourned at 9:30 p.m.

Fourth Business Meeting

The meeting was called to order by President Jack Starr at 4:30 p.m. on April 16, 1983.

Carol Gaede of Moorhead State University, Chair of the Resolutions Committee, read the Convention Resolutions. All resolutions were adopted.

Jim Norwig of the University of Wisconsin-LaCrosse, and Chairman of the Convention Evaluation Committee, gave the committee's report. The Convention's action on each item is listed in the copy of the report (See report). The motion to file the committee's report was approved.

In new business, a motion to adopt the policy of dropping the lowest rank and rate on the six Individual Events ballots failed.

Another motion to provide a 10-3-5 time format for Open Division Debate failed.

President Starr announced that the National Council upon the approval of the Province of the Lower Mississippi had selected the University of Arkansas at Fayetteville and the Fayetteville Hilton Hotel as the next site of the National Convention. The date will be March 20-23, 1985.

The meeting was adjourned at 5:45 p.m.

EVALUATION COMMITTEE REPORT

James E. Norwig, Chairperson

There have been a substantial number of questions, concerns, and complaints about the tournament/convention which were received by the committee. Many of these dealt with matters unique to this tournament or matters which the committee felt were best left to administrative decision: in the

interest of brevity these will not be dealt with in this report. Instead, the chairman of the Evaluation Committee will compile them into a letter to be furnished to the Current President, the President-Elect, the Secretary-Treasurer, and the next Tournament Director.

COMMENDATIONS

MSP 1. The committee would like to commend the National Council for its selection of a truly beautiful and invigorating setting for the 1983 National Convention and Tournament at a bargain price.

MSP 2. The committee commends the practice of printing time limits and abbreviated rules on individual events ballots.

MSP 3. The committee commends the

tournament administration for its efforts to schedule events in as few sleeping rooms as possible and only at reasonable hours.

MSP 4. The committee offers its appreciation to all of those who have and will continue to work so hard to make this gathering a success, and who have so often displayed grace under pressure.

RECOMMENDATIONS

MSF 1. Individual Events should be grouped in *three* Conflict Patterns, with double entry within a conflict pattern permitted.

MSF 2. In the preliminary rounds of all events, other than Discussion, a single judge should be used. In Discussion the present practice of having a resident and visiting judge should be continued.

MSF 3. A final round, composed whenever possible of the top six speakers in the event, should be held in each individual event. From this round a 1st, 2nd, and 3rd place winner should be declared.

DEBATE:

MSP 4. Traditional and Championship Debate Divisions should be abolished, and replaced by an open-debate division, utilizing the 8-3-4 Cross-exam format.

Open and CEDA divisions will have six prelim rounds and appropriate elim rounds based on the number of entries.

Octos = 40 or more

Quarters = 20-39

Semis = 12-19

Finals = 11 or less

MSP 5. For fee purposes, a Lincoln-Douglas debater should not be considered as equivalent to a two man debate team. A single judge should be able to cover four Lincoln-Douglas debaters.

MSP 6. A two minute period should be provided at the beginning of each round in debate, during which the judge may state his/her judging philosophy and/or other relevant information, and/or answer questions from the debaters.

GENERAL

MSP 7. Judges who fail to fulfill judging assignments and/or standby assignments should be assessed a substantial financial penalty.

MSP 8. A substantial nuisance fee should be charged for dropping a contestant from the tournament at the registration table.

MSP 9. A permanent record of procedures and materials used in the preparation and administration of the National Tournament should be established. This record should be kept in the National Secretary/Treasurer's office between tournaments and provided to

each new tournament director.

MSP 10. All ballots should be appropriate to the event for which they are used and should be standardized for use at Pi Kappa Delta National tournaments, and should reflect current judging criteria.

MSP 11. If possible, the tournament schedule should be arranged to allow for a substantial block of time during which neither competition or business meetings are scheduled.

WHEREAS Tony Allison gave liberally of his time and effort in arranging this tournament location.

THEREFORE, BE IT RESOLVED that a letter be sent to the head of his school expressing the organization's deep appreciation for his tireless efforts and that a standing ovation be given him at this meeting.

REPORT OF THE CONSTITUTIONAL

REVISION COMMITTEE

Gary Horn, Chairperson

This report presents the changes in the constitution of Pi Kappa Delta approved at the National Convention in Estes Park, Colorado, April 13-16, 1983. It does not include proposed sections which were rejected.

503 Each undergraduate chapter, to maintain itself in good standing, shall provide itself with a constitution, shall meet regu-

larly, shall initiate new members at least annually using the obligation and ceremony provided by the National Organization, shall report new members and changes in standing of members to the National Secretary-Treasurer, and shall collect membership fees, national chapter fees, and other assessments of the National Organization promptly and forward them to the National Secretary-Treasurer or attend the National Convention at which time these

fees may be paid. All treasurers who are sending money for fees or keys must designate the person or persons for whom the money is being sent.

504 Undergraduate chapters may be placed on probation if the following conditions exist:

504.1 Any undergraduate chapter not submitting five new members every biennium for a four year period or not paying the annual national chapter fee for a four year period shall be placed on probation.

504.2 An undergraduate chapter placed on probation by the National Convention for

any cause shall be deprived of all privileges of membership except for the initiation of new active members, and shall have no vote in the Province or National Organization.

504.3 Probationary status can be removed only by a vote at the National Convention.

505 Any undergraduate chapter not submitting five new members every biennium of the six year period or not paying the annual national chapter fee for the six year period may forfeit its charter upon recommendation of the National Council and approval by the National Convention.

Currently, there are 56 chapters showing no activity. This lack of activity is determined by failure to pay dues and/or failure to attend a National Convention for the last two or more years. There is some hope that some of these chapters can be rehabilitated. The Charter and Standards Committee will make no recommendation on these chapters at this Convention. It should be noted that the Province Governors have a list of these chapters.

Also, one chapter, Texas Christian University, is inactive but has requested to remain in PKD. Their situation is currently under consideration by the Charter and

Standards Committee. The Committee is determined to work with any chapter wishing to retain its PKD membership.

Eight Chapters have formally requested disaffiliation by letter. Those chapters are requesting disaffiliation because they no longer have programs or they wish to affiliate with DSR-TKA. They are:

Monmouth College - Illinois Zeta - Province of the Illinois

Central Connecticut State College - Connecticut Gamma - Province of the Northeast

The Charter and Standards Committee recommends that the 1983 Convention honor these requests and support the disaffiliation of these chapters from Pi Kappa Delta.
