Ripon hosted the inauguration ceremony in conjunction with their Founders Day activities. THE DEDICATION OF THE PI KAPPA DELTA HALL OF FAME

The Pi Kappa Delta Hall of Fame was officially dedicated at Ripon College, Ripon, WI, on February 16, 1996. The dedication of the Hall of Fame was the featured event at the Founder's Day celebration marking the 145th anniversary of Ripon College. Ripon College and Egbert Nichols, member of the Hall of Fame, played a significant role in the founding of Pi Kappa Delta. A reception and dedicatory ceremony took place in Great Hall of the Harwood Memorial Union. Over two hundred guests filled the Hall to hear the remarks of Paul Ranslow, President of Ripon, and David Seligman, Vice President and Dean of Faculty, and three members of Pi Kappa Delta. Gary Horn, Professor of Communication at Ferris State University and Past President of Pi Kappa Delta (1985-87), spoke at the dedication on "The Creation of the Hall of Fame." R. David Ray, Chair of the Division of Arts and Languages at the University of Arkansas at Monticello and Past President (1987-89) and Historian, spoke on "The Meaning of the Hall of Fame." Bill Hill, Jr., Chair of Communication at the University of North Carolina at Charlotte and current President of Pi Kappa Delta (1995-97), delivered an address on "An Expression of Appreciation to Ripon College from Pi Kappa Delta."

Also attending on behalf of Pi Kappa Delta at the ceremony were Terry Cole, Past President (1989-91); Robert Littlefield, Past President (1991-93) and National Secretary; Sally Roden, Past President (1993-95); and Joel Hefling, President Elect. Rhea Bell, a former member of the Ripon forensics squad and student National Council Member (1985-87), was on hand for the occasion. Jody Dalton Roy, Chair of the Speech Department, and Bendicte Bradford, forensics coach, as well as members of the squad represented the Wisconsin Alpha Chapter of Ripon College. A host of friends of Pi Kappa Delta and Ripon College were on hand to help celebrate the occasion.

Nineteen plaques of Hall of Fame inductees depicting their contribution to Pi Kappa Delta and forensics were on display at the dedication ceremony. The Pi Kappa Delta Hall of Fame plaques will be permanently housed in the Kresge Little Theatre in East Hall on the Ripon Campus. East Hall was the site of the first National Championship Debate for the High Schools of America sponsored National Forensics League in May, 1931.

The plaque on display in East Hall describing the Pi Kappa Delta Hall of Fame reads as follows:

"PI KAPPA DELTA is a national honorary forensics organization for intercollegiate debaters, competitive individual speakers, non-classroom audience speakers, and instructors teaching courses in oral communication. Since its beginning in 1913, Pi Kappa Delta has been a national leader in collegiate forensics education.

The Pi Kappa Delta **"Hall of Fame"** was established by the National Council in 1987 to honor those individuals who have made significant contributions to forensics and exemplify the organization's motto "The Art of Persuasion, Beautiful and Just." The first recipients were presented at the 75th "Diamond Jubilee" Pi Kappa Delta National Convention and Tournament at LaCrosse, WI. The 1987 charter members of the Hall of Fame are Georgia Bowman, Theodore O. H. Karl, Roy Mahaffey, Egbert R. Nichols, Larry E. Norton, John Shields, and William H. Veatch. The site for the permanent PKD Hall of Fame is the Wisconsin Alpha Chapter at Ripon College."

Pi Kappa Delta is indebted to Paul Ranslow, President of Ripon College, his staff, and members of the Ripon College Board of Trustees for their generosity in hosting members and friends of Pi Kappa Delta at an outstanding dedicatory ceremony and other special events on this significant occasion in the history of Pi Kappa Delta.

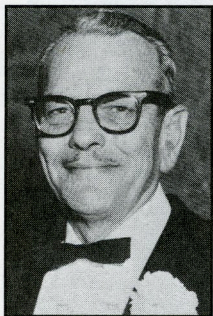

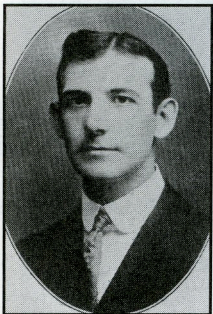
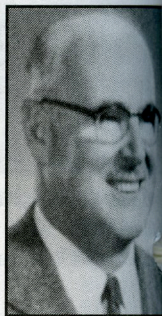
Georgia Bowman, William Jewell College in Liberty, Mo., served as president, 1965-67, vice president, 1963-65, editor of *The Forensic*, 1971-75, and was a member of the national council, 1957-69 and 1971-75. Bowman's caring spirit, wit and knowledge are legendary today in the forensic community.

1987 INDUCTEES



Theodore O. H. Karl served as president, 1967-69, vice president, 1965-67, national secretary-treasurer, 1973-81, as a member of National Council, 1961-71 and 1973-81, and is a 50-year member of Pi Kappa Delta. Karl founded the speech department at Pacific Lutheran University and the Washington Epsilon Chapter of Pi Kappa Delta. He served in every office of Pi Kappa Delta except historian.

Roy Mahaffey served as president of Pi Kappa Delta, 1951-53. He taught at Linfield College in McMinnville, OR, for nearly 50 years and hosted the first, and for many years the largest, forensic tournament in the West. He is credited with inventing Lincoln-Douglas debate and for hosting tournaments with as many as 15 separate individual events.



Egbert R. Nichols was one of the founders of Pi Kappa Delta and modern intercollegiate forensics. He taught at Ottawa University in Kansas, Ripon College in Wisconsin and the University of Redlands in Southern California. Nichols was the first president of Pi Kappa Delta, 1913-18. It was at his insistence *The Forensic* was published to bring the chapters closer together, and he was the magazine's editor from 1915-18. Nichols was known as a very prolific scholar in argumentation and debate.

Larry E. Norton served as president of Pi Kappa Delta, 1957-59. He holds the degree of Special Distinction in the Order of Instruction. He also held national offices of secretary, 1963-73, and historian, 1975-85. Norton, who taught at Bradley University in Peoria, Ill., is well known for his book *The History of Pi Kappa Delta, 1913-87*. He is referred to by his many friends as "Mr. Pi Kappa Delta."
