UNIVERSITY OF ARIZONA

The Arizona Gamma chapter of Pi Kappa Delta was gratified last June to discover that all five of its members

who were graduating were planning to attend graduate schools. Leonard Bower will work on a master's in economics at Duke, John Roberts on his advanced degree in economics at the University of Missouri, Tom Hall in government at Rutgers, Henry Kenski in political science at Georgetown, and Gordon Blount will remain at the University of Arizona as a graduate assistant in speech.

The University debate squad will miss these individuals who did so much to help the squad to its most successful season to date, which reached a climax at the Province of the Pacific convention-tournament in Los Angeles when one of the three senior teams and one of the two junior teams receiving superior awards were from the U. of A. During the last debate season, twenty-five trophies were added to the squad's collection, and University debaters compiled a record of five first places in debate tournaments, seven second places, and four third places. The squad was even more pleased that sixteen different students had a hand in winning one or more of these places.

Currently, the squad is hard at work in anticipation of the new season's opening tournament at Texas Tech. An ambitious schedule involving attendance at approximately twenty tournaments, many of them of a national character, is planned for the current season.

HOPE COLLEGE

This year marks for Dr. William Schrier a quarter of a century of service to Hope College. All in all, it has been an outstanding year of forensic activity. M. Harold Mikle, our debate coach, has taken over the Peace Extemporaneous Speaking Contest. His speaker, Peter Paulsen, won 1st prize in the MISL contest, as also did John Crozier in the Old-line Extemporaneous Contest held on Hope's campus, indicating that that work is now in capable hands. Debaters took part in a total of some 79 debates in a number of tournaments. Plans are under way for next year to improve "town-gown" relationships by expanding considerably the number of audience debates. In addition, this will

provide more experience in an actual audience situation, to say nothing of contributing in some small way toward the formation of public opinion on the national debate question.

In Oratory we've had an exceptionally good year, climaxed by our state winner, Jacob Ngwa, winning 1st place May 8, at Northwestern University, Evanston, Illinois, in the contests of the Interstate Oratorical Association. Jacob is from West Cameroun, a Sophomore pre-med student. Thelma Leenhouts of Holland won 2nd in the Old-line Women's Contest. In the Peace Oratorical Contest, both in the State and Province Contest held at Grove City, James Korf, our Senior speech major, won 1st and Della Rae Kuiper, our woman peace entrant, won 2nd in these same two contests.

At our Provincial Convention in Grove City, we came within one point of winning the sweepstakes cup after participation in Oratory, Debate, Discussion, Extemporaneous speaking and After-dinner speaking. We are looking forward to a good delegation going to Tacoma, Washington, next year to the National Convention. Our year's activities were climaxed at the PKD banquet where Guy Vander Jagt, now a Grand Rapids attorney, gave an inspiring speech on "The Marks of a Good Speaker."

CONCORDIA COLLEGE

Concordia's Zeta chapter has had a busy year both on and off campus. By road, rail, and air Concordia's Zetas traveled to fourteen tourneys and participated in 170 intercollegiate debates.

Included in this year's schedule were the Eau Claire Speech Festival, Northwestern's Owen L. Coon tournament, the Harvard Invitational tournament, and the University of Nebraska tournament. Concordia debaters qualified for elimination round competition at the Heart of the Continent tourney, St. Thomas's Northwest Debate tournament, and the Nebraska tournament. Judy Simundson won first place in oratory in the Heart of the Continent

tourney and the Eau Clair Speech Festival.

The season finale was the bi-provincial tournament at Millikin University. In spite of an outbreak of flu at Concordia, three members participated in the tournament and attended the provincial meeting. Concordia's forensic coach, Dr. Paul J. Dovre, was elected Governor of the Upper Mississippi province.

Paul Arneson was chapter president this year. Under his leadership the squad sponsored an intra-campus debate tournament, student speaker's bureau. Nine new members will be initiated at the spring banquet and the 1964-65 executive officers, headed by president Larry Bakken, will be installed. Freshman Connie Farden, voted the "outstanding debater" by the members of the debate squad, will be honored at the banquet.

CENTRAL MICHIGAN UNIVERSITY

James Bedore, the new president of our Theta chapter, was president of the student body last year. William Primm, a past president of our chapter, was elected parliamentarian for 1964-65. Other officers elected were Susan Dawe, secretary, who will also edit the Chippeewa yearbook, and Judy Epley, treasurer. We are privileged to have strong leadership in the chapter.

A careful study of the forensic season will be made so as to send the largest possible delegation on the big trip to Pacific Lutheran University. Central Michigan hopes to continue its policy of entering all events at Nationals regardless of the distance.

UNIVERSITY OF SOUTHWESTERN LOUISIANA

The University of Southwestern Louisiana's debaters enjoyed an unusually successful forensic season during the 1963-64 academic year.

They won first place honors at least once during the year in senior men's debate, junior men's debate, senior women's debate, and junior women's debate.

Margaret Meagher seemed to be the

University's most successful debater in that she and her various colleagues won tournament championships as follows: Margaret and Gay Ann Patin, Northwestern State College (Louisiana); Margaret and Lois Lyons, Baylor University and Millsaps College. They also rated superior at Louisiana Polytechnic Institute.

Margaret and Therese Trahan won an excellent rating at the Pi Kappa Delta Province Convention.

Charles Dupin and Earl Latiolais won first place honors at Stephen F. Austin State College. Charles and Ted Haik also won a superior rating in debate at the LSA Speech Festival.

The Southwesterners were highly successful at the Baylor University Tournament in that they won first place in junior men's debate, junior women's debate, junior men's oratory, and junior women's oratory.

Some thirty U. S. L. students participated in eight forensic tournaments and one discussion tournament during the year.

DELTA STATE COLLEGE

During the 1963-64 school year, Mississippi Zeta Chapter participated in two regional tournaments and the Southeast Province Convention at Stetson University in Deland, Florida. This year's squad consisted of: Rod Clemmons, Dick Grutzemacher, Anita Pierce, Max Parish, Winston Russell, Clif Irwin, and coach Ray McMillin.

Officers for the coming year are: Dick Gruetzemacher, President; Clif Irwin, Vice President; and Kinston Russell, Secretary-Treasurer. Zeta is looking forward to a successful 1964-65 season.

MONTANA STATE COLLEGE

Members of Montana Beta chapter had another busy season during 1963-64 and look forward to an even bigger and busier schedule in the coming year.

During the past year the 18 members of the debate squad won 117 out of 200 debates in 11 tournaments. Our three Lincoln-Douglas debaters won 46 out of 62 debates. In this event we are especially proud of Gerry Neely who

won 25 out of 31, an outstanding record.

One of the high points of the year was the Gem State at Idaho State University where Gerry Neely and Laury Eck won the championship from the team from the University of Oregon.

The year concluded with the annual spring banquet and initiation. Professor Paul A. Grieder, head of the English department of M.S.C., was initiated as an honorary member at the banquet. Former M.S.C. debaters, Arnold Malone of Alberta, Canada, and Keith Wilson of Bozeman, Montana, were guests at the banquet. 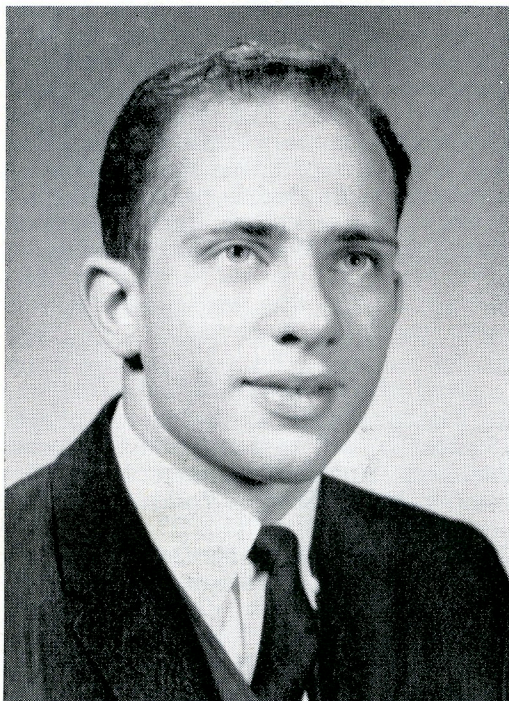

FRESNO STATE COLLEGE

The California NU chapter of Fresno State College is preparing for a vigorous and expanded forensic season under the direction of new Pi Kappa Delta adviser, Dr. A. Kent Marler. This year's calendar for Fresno Pi Kappers includes several tournaments in California as well as trips to Idaho, Nevada, and of course, the National in Tacoma. Highlighting the year will be the inauguration of The First Raisin Center Invitational Tournament with guest directors from five different states. The dates have been set as February 12 and 13, and it is anticipated that Pi Kap schools in the West will be well represented.

WESTERN ILLINOIS UNIVERSITY

Western Illinois University debaters won certificates and trophies in several major tournaments last year. Similarly students representing the University in the individual events of oratory, oral interpretation, and radio speaking brought honor to themselves and the University at various tournaments. Western won a total of three trophies

Recognized also was Ron Lomas for winning a State Department fellowship. Ron attributed much of his success in competing for this award to his debate experience and record. Both Lomas and Leo were also recognized for the 6-1 victory over Harvard University on the proposition: "Resolved, that Cuba should be annexed by the United States."

Pi Kappa Delta officers for the coming year are as follows: President: Nancy Setterberg; Vice President: Vic Leo; Secretary: Rudy Jagielski (first quarter) and Cam Marcucci (2nd and 3rd quarters). Current active membership in Pi Kappa Delta stands at an all time high.

Western will host three intercollegiate tournaments during the forthcoming academic year: on October 24, a novice debate tournament. On February 12 and 13, WIU will sponsor its first championship debate tournament. The event will be switch-sides, conventional. Finally, on March 5 and 6, the University will stage its first annual championship level oral interpretation tournament. Featured will be six preliminary and two final rounds of oral reading.

Pi Kappa Delta Jerry Koehler has joined the forensics staff with the rank of instructor. Jerry is Western's first Master of Arts in Speech graduate. He will also teach sections of the basic course.

Dr. Raymond Tucker begins his fourth year as Director of Forensics.

NORTHERN ILLINOIS UNIVERSITY

Herb Hess, Director of Forensics at Northern Illinois University at DeKalb, has announced plans for several tournaments this year. The Northern Homecoming Invitational will be held October 23 and 24. This tournament is limited to 18 two-man units from 18 schools. The Northern Novice tournament is planned for November 7 and will include three rounds of debate, oratory, extemp and oral interpretation. Entries are limited to 4-man units. On November 21, NIU will be host to high schools in the Northern Illinois area for the annual high school debate tournament. The annual Selke Oratorical contest will again be held in December. Also on the calendar is the Husky Invitational Tournament February 19 and 20, 1965. In addition to the debates there will be a pentathlon of individual events including oratory, extemp, impromptu, discussion, oral interpretation, and after-dinner speaking.

WEST TEXAS STATE UNIVERSITY

This year's first major forensic event at West Texas State University, in Canyon, will be high school debate workshop and tournament to be conducted in the WTSU Fine Arts Building November 13th and 14th.

Special emphasis will be placed on

the high school debate question — Resolved: That nuclear weapons should be controlled by an international organization.

The services of Dr. Glenn Capp, chairman of the Communications Division at Baylor University, have been obtained as special consultant and judge for this project. Other judges and consultants for the event will be drawn from the WTSU faculty, and local bar associations.

A special feature of the program will be a model debate on the high school question by WTSU debaters, with a critique and open discussion by Dr. Capp. Dr. Capp will also discuss techniques at an informal luncheon, and critique the high school debate finals.

This year's enrollment of students is expected to exceed that of last year by a considerable margin, indicating a trend of significant growth for the workshop.

This annual project is sponsored by the Texas Omega Chapter of Pi Kappa Delta, Mary Lemmond, president.

APPALACHIAN STATE TEACHERS COLLEGE

The North Carolina Epsilon chapter, located at Appalachian State Teachers College, is co-sponsor with the Dept. of Speech of a new feature on Appalachian's campus, The Appalachian Campus Forum. This forum will allow students to debate a timely subject each month of the school year. The debates are open to the student body, and will feature student speakers who are not necessarily active on the debate team. The first topic to be debated, in October, is: "Goldwater: a Problem or a Solution?"

The audience will be divided into partisans, neutrals, and opponents, will be allowed to heckle, and will be allowed to vote their opinions at the end of the one-hour debate. Also, audience participation will be allowed following the prepared speeches.

Campus topics, and national issues of a controversial nature will be debated during the school year.
