Dear Brother,

I address you on behalf of the Committee of the Home Mission Board, appointed to effect a settlement in respect to the affairs of Ottawa University.

The Committee held a meeting on Friday last, & presuming that by this time Judge Emery has returned from the East, & that the Board can therefore hold meetings for business, the Committee would respectfully urge the importance of proceeding as rapidly as possible with the remaining items of the settlement.

By the terms of the settlement the 1280 acres of land are to be patented immediately to your Board, that your Board might proceed to select & dispose of these lands, "so far as may be necessary to pay its expenses, including such bills of expenses as may be presented by the Home Mission Society."

Subjoined you will find these bills of expenses. Comparing them with the claims placed upon the Commission, you will observe that the sum of \$ 420.47, incums in expenses by the Society

prior to the attempts to secure remedial legislation, has not been included in the accounts now submitted.

The Committee are aware that the lands cannot now be disposed of without sacrifice, & if it would be more agreeable to your Board, would accept an equitable part of the land itself in satisfaction of their claims. The Committee are as desirous as your Board can be to have their claims arranged in such manner as shall be most economical, & promote the earliest & most successful establishment of the school.

They are anxious moreover to accomplish as early as practicable, the final disposition of the 640 acres with the school building. They would respectfully suggest therefore the early enlargement of your Board by the election of the persons nominated by the State Convention, so that that part of the negotiation may be entered upon. The Committee have no interest apart from the interest of the school, & will be most happy to cooperate in placing it on permanent foundations by a completed title to the property.

I am directed by the Committee to ask that they may hear from you at an early day.
