of "defining their terms" when each of the two cars in which they were travelling was abruptly halted by a flat tire. An immediate "contention" sprang up as to who should be allowed the honor of fixing the flat. A 7 to 4 vote was taken in favor of the men, after which they volunteered.

Thankful for their score of "no losses", the squad secured transportation into Pullman where two of its teams competed successfully, losing only to the final winners of the tournament. Other members of the squad registered too late for contest competition, but won every round entered.

Dr. C. Solberg, faculty member accompanied the group. PLC debate coaches are Professor Theodore O. H. Karl, head of the speech department, and Mr. Jon Ericson.

Phillips University

The Oklahoma Kappa Chapter at Phillips University, in Enid, Oklahoma is keeping quite busy this year. It seems that every year when tournaments are discussed the problem of finances come up to dampen the spirits of the group. Last spring it was decided that no such trouble was to arise this year. Southern Illinois University

Southern Illinois University debaters (Illinois Upsilon) are preparing for the busiest season in the history of the University. More out-of-state tournaments are included in this year's agenda than ever before. Minnesota. In addition, the squad will be represented at the Pi Kappa Delta Provincial, the West Point Regional, and at eight tournaments in Illinois.



On October 22, 215 discussions leaders and participants were entertained at Wisconsin State College in the Ninth Annual Discussion Clinic for High Schools. Pi Kappa Delta members Beryl Royan and Kay Mergen are student co-managers, a very important duty in a school which hosts many tournaments.

The Eau Claire squad traveled to Iowa State Teachers College November 11-12. There two debate teams survived undefeated. First place in oratory and second in extemporaneous speaking and a second-place tie in discussion were won by Eau Claire.

On November 14, Pi Kappa Delta sponsored the Fifth International Debate between Cambridge University and Eau Claire. For the first time in our college's history, two women debated for Eau Claire. They were the president and historian of our chapter, Rose Pribil and Patricia Litsheim.

A delegation of 24 Eau Claire speakers represented the college at Bradley University Tournament November 18, 19, and 20. Eau Claire's overall record of 18 Superior and 34 Excellent awards was more than double the number won by any other school participating. Among the Superiors were three undefeated debate teams.

Ridin' the Provinces

All too often the chapter notes in *The Forensic* are read only to see what is said about our friends. This is one purpose of publishing them, but they also answer a persistent question — what is the place of a national honorary Forensic fraternity on a college campus? Of course, one purpose of a fraternity like Pi Kappa Delta is to honor those students who participate in forensics on their own campus, in the local area and in general. These projects cannot exist without the help of a local organization.

At *Phillips University*, for instance, the very real problem of financing forensics was partially met this year because Pi Kappa Delta edited and published a student directory. At *Linfield College* the trip to the National Convention is financed every two years with a variety of unique schemes.

Many of our colleges sponsor intercollegiate speech tournaments and clinics but pity the poor forensics director who finds himself burdened with the whole job. At college after college tournaments are made more enjoyable because the local chapter steps in to carry much of the load.

The high school tournament or clinic is another area. High school debate can die in an area without the support which the active interest of a college can give. The active direction of meets by Pi Kappa Delta schools like St. Olaf, Chico State, Baylor and Washington State does much to increase activity in the high schools. Pi Kappa Delta members can act as judges, chairmen, tabulators and hosts. The local school is aided by bringing high school

students to the campus some of whom will return as college debaters.

Perhaps our most active chapter in supporting high school forensics is *Kansas State Teachers College* at *Emporia*. They stage a demonstration debate tour during the first two or three weeks of October at which time they provide an analysis of the question and a demonstration debate. They also publish a news letter for high school debaters with a circulation of over 1,000.

The local chapter also provides a basis for linking present and past in forensics. If a school is lucky enough to have the same forensics director over a period of many years a personal link is established. However, college professors are a mobile lot and an organization can serve to unite the forensic spirit on a campus. Upper Iowa University has an Alumni Breakfast each year at commencement. At Southwestern College the Alumni Banquet is an annual affair. This year it was addressed by Dr. J. Thompson Baker, former Forensics Director and co-founder of the first Intercollegiate Debate Tournament.

The Midland College chapter, like many others, sponsors a Fall Mixer for outstanding freshman speech students and beginning debaters. Eastern Illinois, Michigan State and Upper Iowa sponsor intramural speech tournaments. Such programs can aid greatly in encouraging students to enter forensics.

There are also activities which will bring all debaters together regardless of their school. On December 15, Governor Grace Walsh will have an open house for all Pi Kappa Delta members in the area. For fifteen years *Simpson College* and *Central College* have held joint initiations once a year. This provides a real tradition which unites debaters from different schools.

At *Linfield College*, the Pi Kappa Delta chapter is going to aid the fraternity by staging a get-together with one of the non-fraternity schools that has expressed an interest in Pi Kappa Delta.

On-campus debate and discussion programs, such as those sponsored at *Illinois Normal* and *Michigan State*, help to increase the interest in current affairs among the members of the student body. *Emporia State* is meeting the problem of the general public's lack of knowledge about debate. They will participate in a television show to provide information about how debate programs are organized and run. Perhaps, such activities will help prevent such unfortunate situations as the difficulty we had last year in debating the recognition of Communist China.

Naturally, there are many more things that a chapter can do and we could almost list every chapter in doing some of these activities. If you have any unusual projects in your chapter, let us know about them. This brief look at what some chapters are doing will indicate what Pi Kappa Delta can do on a college campus.

Row, Peterson & Co. announced this fall the publication of *Speech For You*, a high school text written by Dr. George Pflaum, past President of Pi Kappa Delta and Charles Masten, Governor of the Province of the Plains. Both these men, from *Kansas State Teachers College* at Emporia, are well known to Pi Kappa Delta and surely we will want to give the book

our support. Of course, this gives us divided loyalty because President Ted Nelson's book for high schools, Speech and Your Personality, which he wrote in cooperation with W. Kirtley Atkinson of San Luis Obispo, California High School, also merits our attention. Published by Benjamin H. Sanborn & Co. of Chicago, it, like the Pflaum and Masten book, relies on many years of experiences in teaching beginning students. Oh, one more thing, both books have cartoons!

A quick glance at the S.A.A. and related organizations convention turns up some Pi Kap names. Iim Stansell of Los Angeles State was in charge of Registration. Glyn Riley of Pepperdine College read a paper on "Debate Tournament Administration-A Survey." Earnie Bormann of Eastern Illinois State read a paper on "Ghost Writing Agencies." John Baird of Modesto Junior College and former National Convention winner at College of the Pacific spoke on "The Pre-Seminary Speech Program for ministers." Jim Jackson of Pasadena was a judge at the exhibition debate chairmaned by Emmett Long of Pepperdine. Carroll Lahman of Pasadena College was a member of the panel on "The History of Speech Education." Roy Nelson of Colorado A. and M. was on two panels, one on "Organizing the Basic Course in Discussion" and another on "Debate as Persuasive Speech." The panel on "Unique College Forensics Programs" had two B Kap speakers. Ted Karl of Pacific Lutheran and F. Lincoln Holmes of Illinois State Normal University. The chairman for that group was Ted Nelson of St. Olaf. William Stites of Arizona State Teachers College at Tempe spoke on "The Hazards in the Processing of Information Through the Human Nervous System."
