

SOUTHERN CONNECTICUT STATE COLLEGE

Southern Connecticut State's forensic program, with a substantially inexperienced squad, won 35 awards at individual events and debate tournaments, and continued to provide competitive experiences for others through two large home tournaments. Innovations included the establishment of state championships and an expansion of the coaching staff.

SCSC's rookie individual events squad, primarily composed of Greg Denaro, Joe Leary, Lynne Cappello, Fran Bernstein and Tom Quinn, took first place in sweepstakes and 12 trophies home from Mansfield State and were second in sweepstakes with seven awards at Trenton State. At Mansfield, SCSC was the only school to place finalists in all six events. SCSC also won the state I.E. championships.

Ed Marcarelli and Tom Quinn accounted for 10 awards this year as SCSC's best debate team. At SCSC in the fall, they were 5-1 in prelims in off-topic division and defeated Yale in finals to win the event. At Fordham, they were 5-0 but lost finals to CCNY. They won the state championships. They were second best affirmative team at Niagara. Quinn was top speaker in two of his tournaments.

The 5th Annual Southern Hospitality Forensic Tournament attracted 275 participants from 38 schools, with Monmouth winning the cumulative sweepstakes award and Old Dominion taking regular sweepstakes. Three hundred forty-one participants from 48 schools were at the 6th Owl Forensic Tournament where Rhode Island won cumulative sweepstakes and Hunter won regular sweepstakes. Next year these tournaments will add two more events: expository speaking and rhetorical criticism.

SCSC's coaching staff underwent some shuffling of personnel. Professor Seth C. Hawkins returned from a year's leave of absence; Ed Handi's title was changed from Acting Director of Forensics to Director of Debate; and Richard Kropp, former competitor at Mansfield, was added as a new assistant coach in individual events. These three will stay on for 1973-74.
