CONSTITUTION

Ottawa University Women's Club

Article I - Name

This organization shall be known as The Ottawa University Women's Club.

Article II - Purpose

The purpose of the Ottawa University Women's Club is to provide a means of furthering friendly relations among members through social contact, to provide entertainment and instruction by the presentation of simple but stimulating programs, and to provide

an opportunity for campus and community service through organization as a unit.

Article III - Membership

Section 1. Active membership shall consist of (1) women members of the faculty, (2) women administrative officers, (3) wives of faculty men and administrative officers, (5) full time secretaries except the wives of regular students, and (6) the wife of the pastor of the First Baptist Church.

Section 2. Eligibility continues during the time of active connection with the University.

Section 3. Honorary membership may be conferred upon retired members by unanimous vote of the club upon recommendation of the membership committee.

Article IV - Officers

Section 1. The officers shall be president, vice-president, and secretary-treasurer.

Section 2. Officers shall be nominated by a committee appointed by the president at the March meeting. Election shall take place at the April meeting and shall be by oral vote, a majority vote of those present being necessary to elect.

Section 3. Officers shall be elected for a term of one year beginning June 1. No officer shall succeed herself.

Section 4. Nominations to fill vacancies in office shall be made by the remaining members of the executive committee and acted upon by the club.

Section 5. The executive committee shall consist of the elected officers of the club and the chairmen of standing committees. It shall meet at the call of the President to make recommendations, transact any business of emergency nature and business not of sufficient importance to bring before

ARTICLE V - Scholarships

Section 1. Scholarships awarded by the Ottawa University Faculty Women's Club shall be given bi-annually to a woman student, three weeks prior to the end of the first and second semesters. Each scholarship shall amount to \$50.00 and shall be applied toward tuition.

Section 2. At present, one scholar-ship per semester shall be awarded. The number of scholarships awarded per semester may increase in the future, as the Ottawa University Faculty Women's Club treasury can

accommodate them. In the event there are insufficient funds in the treasury, the awarding of further scholarships shall discontinue until such time as funds are available.

Section 3. A scholarship may be awarded to the same student as often as the Scholarship Committee sees fit to do so.

Section 4. The Scholarship Committee shall consider a student for the scholarship if she meets the following requirements:

- 1. She must have a grade average of 1.5 or better.
- 2. She must establish evidence of a need.
- She must have an acceptable personality and a neat appearance.
- 4. She must strive to uphold and enhance the fine spirit of Ottawa University.

Article VI - Quorum

Two-thirds of the membership shall constitute a quorum.

Article VII - Amendments

This constitution may be amended at any regular meeting of the club by a two-thirds vote of the members present upon the recommendation of the executive committee.

By-Laws

Article I - Duties of Officers

Section 1. The president shall (1) preside at all business meetings, (2) serve as chairman of the executive committee, (3) appoint all committees and be ex-officio member of them with the right to vote.

Section 2. The vice-president shall preside in the absence or at the request of the president and serve as chairman of the program committee.

Section 3. The secretary-treasurer shall keep a record of proceedings of all meetings, keep an accurate classified list of the membership of the club, receive and keep a record of all funds, and disburse funds as directed by vote of the club.

Article II - Committees

Section 1. The program committee shall include the vice-president as

chairman, the wife of the president of the University as an ex-officio member, and four other members. It shall be the duty of the committee to plan the year's program and prepare the year book.

Section 2. The membership committee shall consist of three members whose duty it shall be (1) to compile a membership list to be included in the year book, and (2) present new names for active or honorary membership. One member of this committee shall be retained each year.

Section 3. The courtesy committee comprising three members shall, upon

appropriate occasions, express the sentiment of the club.

Section 4. The Scholarship Committee, composed of the president of the Ottawa University Women's Club, the Chairman of the Finance Committee, the Dean of Women of Ottawa University. the wife of the President of Ottawa University, and one member elected by the club, shall choose, from lists available in the Business and Personnel offices, a suitable candidate for the scholarship.

ARTICLE III - Dues

Section 1. The annual dues of active members shall be four dollars.

January 1 shall be reminded by the secretary.

Article IV - Meetings

Section 1. The club shall hold regular meetings on the first Wednesday of each month at 8:00 p.m. October through May.

Section 2. A called business meeting may be held upon the recommendation of the executive committee.

Section 2. Members failing to pay by January 1 shall be reminded by the secretary.
