SMITH RESIGNS AS O. U. HEAD

EFFECTIVE AT CLOSE OF PRESENT SCHOOL YEAR

Trustees Express Appreciation of His Work—For Stronger Foot-ball, Fees Reduced Chandler Offers \$50,000

The most important The most important matter presented at yesterday's special meeting of the board of trustees of Ottawa University was the resignation of Dr. Erdmann Smith as president of the University, effective at the close of the school year, June 30. He stated that although he would be glad to give much time in soliciting money for capital funds of the institution, he is unwilling to continue soliciting funds for operation. The resignation was accepted by the board, with regret. Dr. Smith said he could not announce his future plans at this time. June 30 will complete Dr. Smith's seventh year as president. A committee was appointed to seek a successor.

Yesterday's meeting of the board was called three months earlier in the year than is customary, to consider finances, the budget for the year 1931-1932, and other matters.

During the period of the presidency of Dr. Smith, Ottawa University has received in cash, gifts averaging over \$4,500.00 a month, and he is leaving in the treasury of the institution pledges yet to be collected amounting to over \$261,000.00. Approximately \$25,000 of this is in the form of certain receivables for which the institution has already qualified.

It was recognized by the trustees that during the six years for which records are complete Ottawa registered almost as many students as in the previous eight years and sent out only seven fewer graduates than in the previous 11 years, and that capital assets were increased by a little over \$133,000.00.

Tuition and Fees Cut

The trustees adopted the re-commendations that the tuition and incidental fees be reduced from \$6.00 to \$5.00 per credit hour for the second semester of this session, the only remaining regular fees, registration and student activity to continue without change.

Dr. Cassidy as Field Agent

Dr. Geo. W. Cassidy, of Wichita, was requested by the board to undertake the collection of \$25,000.00 between January 1, 1931, and May 31, 1931 from pledges which have been secured since Dr. Smith became president.

President Smith was relieved of the burden of soliciting funds for operation for the remainder of his tenure and was asked to continue the administration of the affairs of the college just as he would had he not offered his

resignation.

It was voted also that Ottawa University put on a first class exhibit at the Northern Baptist Convention to be held in Kansas City, Mo., the latter part of next May.

Chandler Offers \$50,000

A climax of the meeting occur-red when Mr. C. Q. Chandler, of Wichita, announced an offer of \$50,000.00 on conditions to be stated later by him.

OTTAWA UNIVERSITY.

In response to the call for a Special meeting, the members of the Board of Trustees of Ottawa University met in Administration Hall, Tuesday 10, A.M. December 2nd, 1930.

W.C.Coleman Chairman of the Board called the meeting to order, and W.P.Blunt of Cawker City, led the Board in prayer.

The following members of the Board were present: W.C.Coleman, C.Q.Chandler, Arthur Willis, J.V.Mitchell, C.G.West, Ben Bowers, E.M.Carr, G.W.Cassidy, J.S.Henderson, W.A.Eose, P.O. Hegberg, Fred P.Martin, J.T.Crawford, Guy Wimmer, F.O.Hetrick, W.A.Elliott, Nort Atkinson, G.F.Allen . Sitting in with the Board Deans W.P.Behan and W.B.Wilson.

President Smith stated the purpose of the meeting and placed into the hands of the members of the Board and elaborate Report of the present situation, giving detailed account of many things concerning the affairs of the University. Various matters of very great interest and value were contained in the Report!

W.A.Rose , Treas urer , gave his Report , and placed in the hands a comprehensive statement of the financial affairs of the institution. He called particular attention to the last page of the Report which gave the estimated indebtedness and the estimated income. He saw no way to finance the school after February unless some way was provided by the Board.

At 10.30 the Board adjourned and attended the Chapel service for thirty minutes .W.C.Coleman spoke to the students.

Following the chapel service the Aboard went to the Nelson Hotel for luncheon, reassembling for business at 1.30 p.m.

Two students of the University appeared before the Board and gave their observations and impressions of the situation on the Campus.

At this juncture C.Q. Chandler addressed the Board and made an offer to double his previous conditional gift raising it to \$50,000. No conditions to the offer were stated , that to be left to further consideration.

With this offer Mr. Chandler Addcated his willingness to pay the salary of G.W. Cassidy in raising \$25,000 or more on outstanding pledges .

On motion by Elliott .Dr. Cassidy was invited by the Board to undertake the raising of the amount , which amount is necessary to tide the School over the second semester . Dr. Cassidy took the matter under consideration .

On motion the Board unanimously voted an expression of appreciation of the generous offer of Mr. Chandler , and pledged every assistance in raising the amount.
