# The President's Message

At my school at this time of year, as teachers are getting ready to evaluate students, we also let the students evaluate the teachers. A few years ago in a cooperative venture, our Faculty Senate and Student Senate developed a teacher rating system. At the end of the year students anonymously respond to a wide range of questions concerning instructors' teaching methods and techniques. Student responses are fed into the college data processing equipment and each instructor and his department head get a profile of student reaction to every teacher. The final question on the test instrument is: "Would you recommend that another student take this course if it were not required?"

That question, it seems to me, has merit for all of us in forensics. And this is the time of year to ask it. Would you recommend that a bright student with no prior background in interscholastic debate be exposed to intercollegiate forensics in your chapter of Pi Kappa Delta?

Most of you, I trust, will answer an unqualified, "Yes," to that question. To learn to influence others through the spoken word and to develop a keen sense of moral responsibility for your speech acts should be the nub of your debate

training. If they have been, no doubt about it, you will recommend your experiences in debate to someone following your educational path.

If you cannot honestly endorse participation in debate to another intelligent student at your school, then something is seriously amiss either with you or with the forensic program to which you have been exposed.

Theodore Roosevelt is credited with saying, "Everyman owes some of his time to the upbuilding of the profession to which he belongs." A clear application of his philosophy touches the debate program at your school. If you believe in it, those of you returning to school next year owe something of your time, not merely to your own preparation for debate, but to activities of the local chapter, to furtherance of all speech activities on your campus, and to encouraging and assisting young debaters who will join the squad next fall and be confused, perhaps intimidated, by the demands placed upon them.

To those of you who are graduating, you have incurred a debt as well. Remember when you were initiated into Pi Kappa Delta? Your chapter president said, "The founders of our fraternity saw clearly that

in the instrument of speech man has been granted a great power which from the beginning of history he has exercised whether for the betterment of his fellows or for their destruction." Keep your accounts straight. If your college debate

career has helped you, then take your insights and skills in persuasive discourse into the world and use them wisely and honestly.

That's the finest endorsement anyone

can provide.

### Speaker Points

To the Editor:

I must raise a dissenting view in response to Marvin Kleinau's negative generalization about the contest event of rhetorical criticism, printed in the March Forensic. I would certainly disagree with his statement that "at best our experience has been disappointing." I regard rhetorical criticism as one of the best of the typical contest events, offering much opportunity for original and creative thought and expression. Apparently Professor Kleinau and I have had very different experiences in judging rhetorical criticism contests, for I could not agree that "few students have entered the activity with any real understanding of its purpose." By far the majority of students whom I have judged in this event made clear their understanding of their critical and evaluative purpose; and I have yet to hear a contestant count similes or syllogisms in speeches by Bryan or Lincoln. Indeed, most rhetorical criticisms which I have heard have dealt with contemporary speakers, and would — in my judgment admirably fulfill the objectives which Professor Kleinau sees as valuable for forensic events; that they provide meaningful and practical experiences which are educaationally sound.

Perhaps the "speech criticism" event which Professor Kleinau describes will prove to be of value. From that description, however, I would hardly expect it to have the educational or critical benefits which a student may derive from preparing or hearing a carefully developed analysis of a significant public speech of our day.

Insofar as my "two modest proposals" constituted a change from the status quo of some tournament practices, I suppose I assume the burden of proof and the affirmative position. Therefore, I request some rebuttal space.

I agree with Dr. Mahaffey's assessment of the "ethics" of tournament management. Unfortunately, there are some people in the forensic community who have questionable ethics. These are the same coaches who use graduate assistants as team researchers, have "full-ride" debate scholarships and generally practice

a win-at-all-cost philosophy.

My second point might be construed as an argument ad hominem. I couldn't help but note that Dr. Mahaffey attempted to establish his basis for argument by mentioning his experience with over 300 tournaments. Is this not an ethical appeal? I am very happy to hear that none of the tournaments that Dr. Mahaffey has administered have been improperly run. What I am contending is that some tournaments are mismanaged and manipulated.

Perhaps my "modest proposals" should have appeared in the publication of some other organization, for I am reasonably sure that no Pi Kappers would be guilty of the practices that are so abhorrent to those who believe in "The art of persuasion, beautiful and just."
