Section eight (Sec 8) and the whole of Section Seventeen
Sec 17 in Township sixteen (T 16) & Range Twenty
R 20 in Franklin Co Kansas as by reference
to said deed of trust will fully appear.

And whereas said lands are subject
to a mortgage for \$2000 dated Sept 4 1868 &
recorded in Book L Page 37 one of the mortgage
records of said county with interest thereon
and said mortgage is now being foreclosed
in the District Court of said county by one
Sneadway the present holder thereof and
it has therefore become necessary to raise funds
to save said property & by paying of said
Mortgage
