Harold R. Husted won his right to speak at Lexington at the Central Interstate at St. Paul, Minn., in July of 1916 in connection with the Prohibition National Convention. As a freshman he first made the debating team and took first place in the state and interstate Peace contests, speaking in that series at the Lake Mohonk, N. Y., national. He has been quarter back on his foot-ball team and is a local and state officer of the I. P. A.

Monta C. Smithson, representative of the Western Section, is a senior at McMinnville College, Oregon. Besides winning the I. P. A. honors through three stages, he is the winner of the state contests of the Old Line and Peace Contests and the '94 college oratorical prize. Smithson has been president of the Y. M. C. A. and local and state president of the I. P. A.

The National Convention

There are Friends, College of Emporia, Cooper Kansas Wesleyan and others that might be debated. Now is the time to make arrangements and plan the finances. What do you say? It's up to you.

This scheme is practicable—reason—Redlands arranged a trip for the last National Convention, carried it out and had three men there. They expect to do it again. What they have done you can do.

This scheme is attractive—reason—it means a great trip for some of your

debaters, and the pleasant experience of a big National Convention.

This scheme is the thing—reason—it will make a successful convention. It will be the biggest thing that has been done in the Forensic world. Let's put it through.

Kansas chapters, don't wait for the visitors to ask for an opportunity to

come, invite them, challenge them-any way to get them to come.

Here are some imperative chapter duties:

Get ready to initiate new members.

- (a) Get blank membership applications (apply to the National President).
- (b) Get catalogue cards to send the record of each member in to the Forensic (apply to National President, Secretary or Treasurer).
- (c) Get cards from National President to report changes of standing of charter members.

Make sure you have copies of the Ritual and ceremonies of initiation. (National President has some extras if you haven't any copies.)

Get a cut and a chapter letter ready for the Annual Number of the Forensic.

Pay up all dues and initiation fees immediately, promptly, pronto—so that there will be an Annual Number of the Forensic.
