WELCOME TO A NEW YEAR, 1992! This year is an even-numbered year, a Province Tournament year. Information about the several province and joint-province tournaments is provided on the last page of the 1992 directory. The Directory provides the names of the tournament hosts and directors and addresses and telephone numbers.

NEW MEMBERSHIPS. As you prepare for the province tournament, do examine your list of entrants. Some provinces require membership in Pi Kappa Delta to assure receiving awards. Membership applications were sent to chapters with the fall mailing. Several will be included with this mailing. A constitutional amendment passed at the last convention adds a grade-point average requirement. New members are expected to have a cumulative GPA of 2.0 on 4.0 grade scale. It is likely that competent members of your forensic team will all meet that standard. We would expect that coaches will be aware of any academic weakness of their squad members. We will not require a transcript or other verification of GPA. We will trust the local chapter and its sponsor to determine the academic standing of those they invite to membership. If the local chapter and its sponsor sign the application for membership, we will trust that the prospective member meets the current requirements. The cost of a lifetime membership is still only \$20.00. There is no yearly membership fee and no fee for advanced standing.
