

PKD National Tournament and Convention Overview

Judge/Critics

One necessity of a good tournament is responsible, reliable judge/critics giving good constructive criticism to students in debate and individual events. Judges must pick up their ballots and get to their rooms on time. Judges must carefully note the correct competitors, sides, speaking order, and other bookkeeping necessities on the ballot. Judges must then render a fair unbiased decision giving a win and a loss in debate and speaking rankings and ratings in either debate or individual events. Judges must then justify their decisions and give constructive criticism to the students, preferably both orally (briefly and succinctly) and on the ballot. What things were the students doing well that need to be reinforced and continued? What things were the students having problems with and how might those weaknesses possibly be overcome?

Forensics educators teach "the art of persuasion beautiful and just" by being good judge/critics. This is no easy task. Often critics are moved around all day having to hustle from round to round. Often critics need to catch a break for food or drink or other necessities. Often critics are tired from late nights and early mornings. However, the tournament can't run unless the judges pick up their ballots and fill them out correctly. And students won't learn or won't learn nearly as much as fast, unless judge/critics stay alert and do their damnedest to give good decisions and to give students lots and lots of feedback on how they might improve.

PKD has some wonderful judge/critics whom we all appreciate. They deserve to be remembered and cheered. PKD also has a few judge/critics who may have forgotten how fundamental and necessary the basics of judging and critiquing are. The tournament doesn't run and the students don't learn unless the judge/critics do their job.

Communication

PKD's continued existence and expansion is dependent on good communication. The National Council must communicate its vision to the provinces. The province governor and lieutenant governor must communicate with active chapters getting them to attend province and national tournaments and initiate new members. They must also try to get new chapters to enroll in PKD.

We have lots of channels for good communication but sometimes we don't utilize them all or use them effectively.

Governors, lieutenant governors, and student lieutenant governors frequently have great ideas they can and should share with one another about how to get new chapters, how to have bi or tri province tournament/conventions, about how to get new members, and about service projects on campus or in the community, etc. etc.
